1	Do you have a person responsible for fire safety in your company (name in comments section)?				
2	Do they have a nominated deputy (name in comments section)?				
3	Do you have a method of raising the alarm in the event of an emergency ie verbal shout, klaxon alarm? (method in comments section)				
4	Have your staff been instructed in how to raise the alarm? Please don't forget to include any temporary staff				
5	Do you have sufficient fire risk extinguishers available of a suitable type and size? If you are use LPG on site a minimum of a 5kg powder extinguisher must be provided for every 2 cylinders				
6	Have your fire extinguishers been inspected in the last 12 months by a competent person/company?				
7	If you are cooking on site do you have a fire blanket?				
8	Do your staff know how to use a fire extinguisher?				
9	Will your fire extinguisher be positioned where it is available for easy use? (not in your van)				
10	Is "no smoking" signage clearly displayed at the entrance of your stand/exhibition? Not required for 3M x 3M gazebo or individual trading spaces in marquees.				
11	If your tent/marquee is over 6.5M in length – do you have an additional exit(s) which has suitable fire exit signage?				
12	Are your fire exit routes kept clear and not obstructed by vehicles, stock etc.				
13	Are all staff aware to keep the area tidy and free from trip hazards				
14	Have you calculated the safe occupancy numbers in your structure				
15	Training records for staff/volunteers should be available for inspection if required – Do you have training records for your staff?				
16	Are combustible materials stored away from any ignition source?				
17	Have all electrical items been PAT tested? Paperwork may be requested on show site				
18	Have all gas appliances been inspected by a Gas Safe Registered engineer? Paperwork may be requested on show site				
19	If you have LPG is this stored outside your marquee and secured so that it cannot be knocked over or tampered with? (cylinders must still be accessible in an emergency)				
20	Are you aware that petrol generators are NOT permitted on site unless an integral part of a unit.				
21	Are you aware that you must not sell/exhibit certain items eg fireworks, garden flares, lit tea lights household candles etc? (unlit tea lights/candles are acceptable)				
22	If you sleep on site do you have a battery smoke detector in your tent/marquee/van?				
23	Have you read the terms and conditions for exhibiting at this Show? If not please ensure that you do so before the event.
